All members of Nene Valley H.O.G. Chapter are welcome and encouraged to bring guests to our Chapter events. Nene Valley H.O.G. Chapter runs 3 types of events:

Open event – open to all H.O.G. members and their guests plus selected guests invited by the Director.

Closed event – members can bring 2 guests and direct family members such as partners / spouses and children.

- Please Note: Children may be excluded from certain age restricted events.
- 3. Members only event only one guest allowed.

All members are allowed to bring guests to Nene Valley H.O.G. Chapter events, as long as they comply with the following:

- They have made their guests known to the event organisers.
- They and their guests have signed this disclaimer.
- They agree to be responsible for their guests at all times.

• They ensure that their guests have fun, but conduct themselves in an appropriate manner befitting a family orientated organisation at all times. Where a guest is also riding it is the members' responsibility to ensure that their guest understands our riding policy, and asks the guest to spend a few minutes with a Road Captain. The Road Captain will go through our riding policy and then ask the guest to sign this disclaimer. If they do not sign this disclaimer and agree to abide by our riding policy then they will not be able to ride with us. A riding guest should, in normal circumstances, be limited to 2 rides per season. If they want to ride more than 2 times with The Chapter then they should be asked to become a member in their own right. Guests' attendance at riding events will be recorded by the Road Captain leading the ride and reviewed on a monthly basis by the Head Road Captain.

You are deemed to be in control of and responsible for your vehicle and your riding at all times, irrespective of ANY GUIDANCE or INSTRUCTION from any of the road captains. You must ensure both the safety of yourselves and other road users; you must at all times ride within the law and obey road traffic regulations. If a road captain feels that your riding represents a danger to you or any other road users you will be asked to leave the ride out. This is not negotiable. By participating in this ride you agree to these conditions.

I agree that the Sponsoring Dealer, H.O.G., H.O.G. Chapter Officers, Harley-Davidson Inc., Harley-Davidson Motor Company, Harley-Davidson Europe Ltd, and any of its corporate affiliates, and their respective officers, directors, employees and agents (hereinafter, the "RELEASED PARTIES") shall not be liable or responsible for damage to my property occurring during any H.O.G. or H.O.G Chapter activities and resulting from acts or omissions occurring during the performance of the duties of the Released Parties, even where the damage is caused by negligence (except wilful intent).

I understand and agree that all H.O.G. members and their guests participate voluntarily and at their own risk in all H.O.G. activities and I assume all risks arising out of the conduct of such activities. I release and hold the "RELEASED PARTIES" harmless from any loss to my property which may result from my participation in H.O.G. activities and events. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE THE "RELEASED PARTIES" FOR ANY DAMAGE TO MY PROPERTY ARISING FROM OR IN CONNECTION WITH THE PERFORMANCE OF THEIR CHAPTER DUTIES IN SPONSORING, PLANNING OR CONDUCTING SAID EVENT(S), EXCEPT IN THE CASE OF WILFUL INTENT BY THE RELEASED PARTIES. Nothing in this disclaimer is intended to release any party mentioned herein for any liability for injury or death caused through that party's negligence. By signing this Release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the "RELEASED PARTIES".
